3. Bidding will be conducted through open tendering with sealed bids and in full compliance with the provisions of Malawi's Public Procurement and Disposal of Public Assets Act Number.27 of 2017 and its subsidiary registrations. Bidding is open to Malawian citizen Bidders who will be required to submit copies of their national identification cards.
4. Bidders will be allowed to bid for one or more motor vehicles of their choice. However, successful bidders will only be allowed to purchase one motor vehicle.
5. In line with Public Procurement and Disposal of Public Assets Act 2017 s.35, EGENCO staff or their relatives (children, spouses, siblings, parents or guardians) will not be allowed in the bidding process.
6. **Mandatory** viewing of the motor vehicles can be done during working hours only upon arrangement with the Chief Maintenance Engineer on **(+265 888 169 169)** or bkanyika@egenco.mw from 08:00-16:00hrs local time (Monday to Friday except on public holiday). All bidders are hereby notified that they **must sign** a designated viewing register when inspecting the disposed motor vehicles.
7. Successful bidders will be required to pay 50% of the bid value as deposit within 14 days from the offer date and balance to be paid within 14 days after transfer of title.
8. Sealed bids marked with the disposal reference number should be deposited in the tender box on or before Thursday 27 March 2025 at 14:00hrs local time. Electronic bidding will not be permitted, and late bids shall be rejected. Bids will be opened in the presence of bidder's representatives who chose to attend at the address given in 9 (c) below at 14:00hrs local time on Thursday 27 March 2025.
